

SUNDAY, JUNE 16

Students arrive independently in Beaune and check in to 4-star Hotel Henry II - Beaune Centre, located close to town center. Evening on your own in town.

MONDAY, JUNE 17

Breakfast at Hotel.

Christian Oggenfuss will provide an introduction to the week and region of the Côte-de-Beaune and Hautes-Côtes-de-Beaune with a representative tasting of the region. Gourmet lunch at local restaurant with wines.

An exploration of the Grand Cru vineyard of Corton.

Visit to a great producer like Maison Bichot or Louis Jadot.

Welcome dinner in Beaune.

TUESDAY, JUNE 18

Breakfast at hotel.

Live instruction on the wines of Côte Chalonnaise with guided winetasting. Visit the famed Côte Chalonnaise region of Mercurey with a presentation in the vineyards.

Lunch at Châteaux de Chamirey Domaines Devillard in Mercurey.

After lunch back to Côte de Beaune vineyards for an educational stroll through the vineyards of Grand Cru Le Montrachet.

Visit and tasting at Henri & Gilles Buisson in St Romain or Domaine des Terres de Velle in Auxey Duresses. Back to Beaune for a guided visit to the Hospice de Beaune and visit "Athenaeum Bookstore- a wine geeks mecca!

Evening on your own.

WEDNESDAY, JUNE 19 | Mâconnais/ Pouilly-Fuissé

Breakfast at Hotel

Live instruction on the wines of the Mâconnais with guided wine tasting.

Visit Domaine Thibert or Domaine Ferret in Fuissé.

Enjoy a gastronomic traditional Mâconnais local lunch with wines of the region.

After lunch a hike to the not-to-be missed rock of Solutré, followed by a tasting at

Domaine Roger Lassarat in Vergisson

Free evening to explore Beaune and dine on your own.

THURSDAY, JUNE 20 | Chablis & Grand Auxerrois

Breakfast at Hotel

On the bus a discussion of Chablis and Grand Auxerrois.

Visit and Tasting at Domaine de la Croix Monjoie

Guided visit to the Vézelay Basilica

Enjoy a gastronomic traditional Chablisienne lunch with wines of the region.

Visit and tasting at Caves Bailly Lapierre in Saint-Bris-le-Vineux.

Walk and presentation in the Chablis Grand Cru appellation area.

Visit and tasting at a top producer like Louis Moreau, Tremblay, or Simonnet-Febvre.

Afternoon visit two great producers in the Côtes Chalonnaise, like Domaine du Cellier, aux Moines or Maison Faively.

Back to hotel, then evening on your own.

FRIDAY, JUNE 21 | Côtes De Nuits

Breakfast at Hotel.

On the bus, a discussion of the Côtes De Nuits and Hautes-Côte de Nuits' wine and vineyards.

Guided visit followed by a five cheese tasting at Gaugry's, a renowned local cheese producer.

Visit and tasting at top producer like Domaine Faiveley, Daniel Rion, Amiot, or Drouhin-Laroze.

Enjoy a gastronomic traditional local lunch with wines of the region.

Drive along Routes de Grands Cru and a stop at the Romanée-Conti vineyard.

Guided visit of Clos Vougeot castle and vineyards.

Visit and tasting at top producer like Domaine Faiveley, Daniel Rion, Amiot, or Drouhin-Laroze.

Gourmet farewell dinner in Beaune with wines.

SATURDAY, JUNE 22 | Journey home

The end our guided tour of Bourgogne

Check out of the hotel in the morning by 11 am

***IMPORTANT** this itinerary subject to change: every effort is made to keep the itinerary as close as possible to what appears above; however, the final itinerary and wineries/ winemakers included may vary due to wine producer schedules, availability, and factors beyond our control. The wine producers visited during this trip will all be of the highest quality.

Trip fees include:

- Six nights local accommodation

- Three training sessions at L'Ecole des Vins de Bourgogne, including expert guest lecturers/educators, official BIVB materials, and exceptional Wines.
- Multiple, daily intimate visits with some of the best wine producers and vineyards in Bourgogne
- More than 125 wine tastings over the duration of the week
- Local transportation
- Guided cultural visits to the Hospice de Beaune, Athenaeum Wine Bookstore, Vézelay Basilica, the Clos de Vougeot Château, a local cheese producer, and guided vineyard walks

NOT INCLUDED - *Flights and travel arrangements to France and journey to and from Beaune.*

**There is a US \$325 supplement if you are traveling by yourself. This cost is to cover the cost of single-room occupancy at the hotel.

Payment 1: Deposit at booking: \$1,050

Payment 2: 90 days from start: \$2,000

Payment 3: 60 days from start: \$445 (plus single supplement if applicable)

Terms and Conditions

By completing this booking form and submitting payment, you agree to the following:

Contract – This booking form is a contract between you and anyone else traveling with you, and Turicum LLC dba Napa Valley Wine Academy.

Confirmation – Upon receipt of your deposit we will issue you a confirmation invoice. Your confirmed invoice is your confirmation of participation in the tour.

Tour Price – The price of the trip is guaranteed after you have completed the booking form and paid your deposit and received a confirmation invoice from us. We reserve the right to increase or decrease the price of the tour until such a time. **Transfers** – You may change your booking up to 14 days before departure by transferring it to another person of your choosing if you are unavoidably prevented from traveling, provided that they accept all conditions such as room type and arrangements for sharing a room.

Cancellation by us – If the minimum number of bookings required is not reached then we are entitled to cancel the tour, giving you at least 60 days notice. You will receive a full refund, but no additional compensation.

Force Majeure – We cannot accept liability or pay any compensation where the performance of our obligations to you is prevented by force majeure. Such events include but are not limited to, whether actual or threatened, war, riot, terrorist activity, industrial dispute, epidemics, adverse weather, fire, and all similar events outside our control.

Cancellation by you – Cancellations must be notified to us in writing, and receipt acknowledged by us. As we incur costs from the time we confirm your booking the cancellation charges shown below will apply:

60 or more days before departure: Loss of deposits

43-60 days before departure: -50% of tour price

29-42 days before departure: -75% of tour price

15-28 days before departure: -90% of tour price

1-14 days before departure: -100% of tour price

Passports, Visas, and Insurance – It is your responsibility to have a valid passport and any necessary Visas as well as travel and medical insurance failure to do so does not relinquish any of your obligations under this contract. In the event of a medical emergency, you will reimburse us for any costs we incur in taking care of you. We strongly recommend you purchase travel insurance covering full medical expenses, medical evacuation, travel delay, cancellation, and loss.

Property damage or loss – In the event, you damage any property, full payment must be paid directly to the accommodation owner or supplier of services by yourself. In the event you lose any property from theft, we are not responsible or liable. **Law** – USA Law, will be used in the event of any dispute. All disputes will be settled in Napa, California. This contract is binding on the parties and their respective heirs, representatives, and assigns.

RELEASE OF LIABILITY AND INDEMNIFICATION

TO: Turicum LLC dba Napa Valley Wine Academy (the "OPERATOR"), AND ALL TOUR OPERATORS AND ORGANIZERS WHO PROVIDE OR MAKE AVAILABLE FACILITIES, PREMISES OR SERVICES FOR THE OPERATOR, and their respective directors, officers, employees, agents, guides, volunteers, independent contractors, representatives, successors and assigns (collectively referred to as the "RELEASEES").

DEFINITIONS

1. In this agreement, the term "Wine Tour Activities" shall include all activities, events or services provided, arranged, organized, conducted, sponsored or authorized by the Operator in relation to the Wine Tour and other such activities, events, and services in any way connected with or related to the Operator.

Acknowledgment – SAFETY

2. I acknowledge that I am embarking on a wine tasting tour that involves the consumption of alcohol. I take full responsibility for my actions, safety, and welfare during the Wine Tour. I further understand that I will be a member of a group and that I will conduct myself in a way that does not endanger either myself or the group. I represent that I do not have and am not aware of any medical or physical condition(s) that would make it inadvisable for me to: i) participate in the Wine Tour, ii) to consume alcohol, or iii) which would result in any injury or damage to me or others as a result of my consumption of alcohol. I acknowledge that it is my responsibility to provide for my own accident and health coverage while participating on the Wine Tour. The Operator does not provide for any accident or health coverage for any of its guests.

ASSUMPTION OF RISKS

3. I am aware that participation in Wine Tour Activities involves risks, dangers and hazards including, but not limited to: transportation to and from various locations, visiting and touring vineyards and operating wineries including areas that may not be normally open to the public and which may be actively engaged in the production and manufacturing of wine, visiting restaurants, hotels and other places including areas that may not be normally open to the public, the consumption of alcohol at many times throughout the Wine Tour, and the negligence of other participants or guides and negligence on the part of the Releasees, including the failure on the part of the Releasees to safeguard or protect me from the risks, dangers, and hazards of Wine Tour Activities.

4. I AM AWARE OF THE RISKS, DANGERS, AND HAZARDS ASSOCIATED WITH WINE TOUR ACTIVITIES, AND I FREELY ACCEPT AND FULLY ASSUME ALL SUCH RISKS, DANGERS, AND HAZARDS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE OR LOSS RESULTING FROM THEM.

I ALSO ACCEPT RESPONSIBILITY FOR ANY PERSONAL OR PROPERTY DAMAGE CAUSED BY OR AS A RESULT OF MY PARTICIPATION IN WINE TOUR ACTIVITIES.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

5. In consideration of THE RELEASEES accepting my application to participate in Wine Tour Activities and permitting my use of their property, premises, and other facilities and for other good and valuable consideration, the receipt and sufficiency of which is acknowledged, I agree as follows:

TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES, and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer resulting, either directly or indirectly, from either my use of the facilities or my presence on the premises DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, ON THE PART OF THE RELEASEES, AND INCLUDING THE FAILURE ON THE PART OF THE RELEASEES TO SAFEGUARD OR PROTECT ME FROM THE RISKS DANGERS AND HAZARDS OF WINE TOUR ACTIVITIES;

TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any claims or demands resulting from any property damage or personal injury to any third party, which might be made against the Releasees resulting from my participation in Wine Tour Activities and my use of the premises and facilities; That this Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns and representatives, in the event of my death or incapacity;

That this Agreement shall be governed by and interpreted in accordance with the laws of the State of California; and

That any litigation involving the parties to this Agreement shall be brought within the State of California; and

In entering into this Agreement, I am not relying on any oral or written representations or statements made by the Releasees with respect to the safety of Wine Tour Activities, other than what is set forth in this Agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT. BY SIGNING THIS AGREEMENT, I ACKNOWLEDGE THAT I AM AGREEING TO THE FOLLOWING:

I. THAT I AM ASSUMING ALL RISK OF INJURY, LOSS OR DAMAGE WITH RESPECT TO THE EQUIPMENT, THE ACTIVITY I WILL BE PARTICIPATING IN AND THE USE OF THE PREMISES AND FACILITIES;

II. THAT I AM WAIVING ANY AND ALL CLAIMS ARISING FROM ANY CAUSE WHATSOEVER AGAINST THE RELEASEES, ON BEHALF OF MYSELF AND MY HEIRS, SUCCESSORS AND ASSIGNS; AND

III. THAT I WILL INDEMNIFY THE RELEASEES IF ANY SUCH CLAIMS ARE BROUGHT AGAINST THEM.
